Secretary's Report 2021

Dear Pastor, Members and Friends,

This is my 2nd report as Church Secretary here at Woodside Community Church, and what a different year it has been. Less than 4 weeks after our last AGM the reality of the Covid-19 situation came home to roost and we found ourselves in the first of several lock-downs and all church activity ground to an abrupt halt. My role as secretary became rather abbreviated as we turned our focus away from running various church programmes and activities and towards how to keep the church alive and getting God's word out there; I have however, by the grace of God, sought to continue to perform the role of secretary to the best of my abilities over the course of the year.

So, where to begin? Well, this was supposed to be a short report, but in reflecting upon the year it really has been extraordinary and deserves a bit more explanation... At first we thought the lockdown would last a few weeks and all we had to do was muddle through for a bit and everything would quickly return to normal; how wrong we were. We did quickly realise that going on-line with services was going to be essential and our first service on Mothering Sunday was hastily put together by Chris, Esther and myself just using Chris's phone. That was the start of what has now been a year of streaming services on Facebook / YouTube, starting with pre-recorded services all done in our respective separate homes and continuing, as it is now, with live-streaming from Church with semi-professional equipment to bring a pretty slick presentation which enhances the service by not distracting from God's word. What a steep learning curve we had, but how essential it has turned out to be. Special thanks are due to Chris for his dedication to this over the whole year. We did have a brief window September to November where we were able to re-commence services in the church under strict covid rules, which were great, and now we are looking forward to being able to re-open again on Easter Sunday (unfortunately still under strict covid rules).

The other aspect that we have come to rely upon is Zoom meetings. Our Wednesday 'Oasis' time of prayer and reflection has been essential in keeping the church praying together and staying together. We also enjoyed Spike's quizzes every other Sunday for quite a while earlier in the year. And now here we are holding our 2021 AGM on Zoom. Praise the Lord for technology.

So, on to secretarial matters... Our church membership has shrunk a little this year. At the start of the year we had 79 members, but we unfortunately lost three by resignation: Andrew Wadl, Linda Howe and Alan Howe. We were sorry to see them go, but they had their personal reasons to do so and we wish them well for the future. That leaves us with 76 members going into the 21/22 church year – although I am aware of another leaver, but since I have already reported the numbers to the District that will be reported with any other additions or losses at next year's members' meeting.

The Church Board has continued to function as best as possible over the year with continued meetings via Zoom. The Trustees have kept the church infrastructure in good order, the Treasury team have kept our finances in good order, the Stewards have assisted with worship and with representing your interests on the Board and Paula has kept the children's work going through the Sunday services and various activities. A big thanks to everyone.

Our thoughts now turn to the re-opening of the church and, we pray, a gradual return to normality – or perhaps a new normal. Easter Sunday is the start, but will be under the same conditions as before. As we navigate our way through the government easing of lockdown we do see hope for services with more people, with the eventual re-introduction of singing and with the recommencement of some of our wider programs as more and more of us get vaccinated and rules are relaxed. I will do my best to keep everyone informed as things develop in this regard.

I will finish this report by offering sincere thanks on behalf of the Board, and all members and friends of the church, to our Pastor, Erica. What a difficult year she has had to endure. You all know the story, so I won't reiterate it here, just suffice it to say how incredibly grateful we are for her faithful service in this 'Annus horribilis' and how pleased we all were to see her back in the pulpit in the last couple of weeks. God bless you Erica, Tom and David; the prayers of your people go with you everywhere you go and in everything you do, as does our love.

Treasurers Report

TREASURER'S REPORT 2019-2020

Members and Friends

I am pleased to report the Church's Account balance in the sum of £91,874.58 as at the 27th Sept 2020.

Due to the unpresented restrictions in people gathering together for worship and hall lettings due to the covid- 19 virus, this has significantly affected our regular income. For example, tithes and offerings are down by £7,420 pounds and hall lettings are down by £8,121 in the year. This fall in income has been negated by a substantial financial transfer of £21,306.30 from North Watford Church and we also received a gift from a will of £8,666.61.

I wish to sincerely thank Carole Dowty for her support and help in bringing forward these figures and to fully reconcile the income with the bank statements. Thank you Carole.

Since March 2020 Carole and I have been visiting the Church on a weekly basis to collect any payments, tithes/offerings sent to the Church or by mail.

This is a timely reminder that all Gift Aid Rebate comes from tax paying members who give to the church and have also subscribed to the gift Aid scheme. I would encourage all of you who are tax payers firstly to tithe/give and secondly to subscribe to the Gift Aid Scheme so that we can get some money back from the Inland Revenue. There is a simple form to complete and this can be obtained from the office.

For example, the church can claim 25p for every pound a tax payer gives to the church. We can also claim gift aid for cash donations of £20 and under.

I am pleased to confirm that the Church has received Gift Aid in the sum of £11,738.13 for this financial year.

We wish to thank all those who continue to give generously throughout this difficult period and

especially whilst the church building is closed.

Trustees Report

Pastor, Members, Friends

The events of the past year has resulted in the Church building being used a lot less for most of the year. The main users have been the worship team for broadcasts, Naomi and Watford food bank.

Thank you to the team who navigated through all the new regulations to allow us to use the facilities and maintain collective worship the best way possible and thank you to you all who have adjusted and helped along the way.

I found engaging contractors to carry out essential works difficult due to their own circumstance.

The back stairs became squeaky so needed rebuilding; a couple of contractors were engaged but opted out, Chris repaired them. Chris also managed the stage repair and extension; the extra space allows us to maintain distance. The roof needed repairs in two areas, under the round window due to leaks and the front door ridge due to storm Darcy. The back kitchen has had a new tile floor replacing the rotting wooden floor. Further work is to be carried out in this area to make it more usable and useful. I finally binned all the old blue chairs, we had less than 10 that were not broken. The kitchen dishwasher was replaced along with other minor works such as installing a new letter box.

We have versatile facilities that are put to good use, currently the back hall is used for the Watford food bank.

Bruce has faithfully visited the building weekly to carry out safety maintenance and minor works and Naomi has reported issues which keeps us focused.

The manse has had all the certificates and necessary repairs carried out. We have received another full year of rent and are thankful for good tenants.

Please see maintenance spend in the financial report, noting this is Oct 2019 - Sept 2020.

No doubt, when we do return to something like normality, we will find there are various "spring cleaning" tasks that are necessary to keep the building in good order.

Although the building has been effectively closed there are still running costs to be met. These include electricity, water, heating (to protect the building from freezing), refuse disposal, annual testing (fire extinguishers, etc.) and so on. So your faithful giving of tithes and offering has been greatly appreciated.

I close with Psalm 116.


